Board Meeting Minutes for April 27, 2016

Unitarian Universalist Church of Chattanooga

Present: Monique Lewis, President; Buck O'Rear, VP Resources Ministry; Cecile de Rocher, VP Religious Growth Ministry; Linda Park, VP Outreach Ministry; Greg Cruz, VP Congregational Life Ministry; Pam Johnson, Secretary; Daidee Springer, Treasurer; Bill Derrickson, 2015-2016 Assistant Treasurer; Leslie Brock, Past President; Rev. Cathy Harrington, Developmental Minister.

Monique called the meeting to order at 6:30 p.m. Bill lit the chalice and shared a reading. Everyone checked in.

March 27, 2016 Minutes: Daidee made a motion to accept the minutes. Greg seconded and the minutes were approved.

Financial Report:

- Daidee reported that finances look relatively healthy and that pledge income was up as compared to last year. Complete financial reports are attached at the end of the minutes.
- Daidee made a motion that the Developmental Minister's 2015-2016 compensation distribution be recorded as follows. Buck seconded the motion and the motion passed unanimously.

Small variances may occur as the fiscal year comes to a close, but salary, housing, and the total will remain constant.

Daidee presented a proposal for a revision to the Policy Manual (see text box below)
regarding reimbursement of taxes on purchases and moved that the board accept the
proposed change. Linda seconded the motion and the motion passed unanimously.

Proposed Revision to Procedure Manual

Sales Tax

Churches are exempt from sales tax in the state of Tennessee and the Tennessee Department of Revenue has issued a Sales & Use Tax Certificate of Exemption to the Unitarian Universalist Church of Chattanooga. Merchants need this form to excuse sales tax. Some merchants frequently used by the church have the exemption forms on file. Most, however, do not. So it is best to always take a form with you when purchasing for the church. Forms are available in the bin on the outside of the office door. If someone makes a purchase in the state of Tennessee on behalf of the church and neglects to provide an exemption form, sales tax will be added by the merchant. The church will not reimburse TN sales tax.

The state of Georgia does not exempt churches from sales tax. Accordingly, the church will reimburse <u>Georgia</u> sales tax if buying from a merchant that does not have a Tennessee outlet in or near Chattanooga.

Those who use the church credit card in TN also need to provide merchants with a sales tax exemption form. If no exemption form is used and TN tax is charged, the amount of tax is owed to the church by the purchaser.

Currently in Procedure Manual

Sales Tax Reimbursements

The church, as a nonprofit organization, is exempt from paying sales tax. For all purchases made on behalf of the church, a Sales Tax Exemption form is given to merchants at time of purchase that precludes adding sales tax to the purchase total. The tax exemption forms are available in the church office. Also, merchants the church often uses have the tax exemption number on file so that forms are not needed. The office administrator can provide advice on which merchants these are.

If the member makes a purchase on behalf of the church and neglects to provide an exemption form, sales tax will be added by the merchant. The amount of the tax will not be reimbursed to the member when the receipt is submitted. Instead, the member may make a copy of the receipt and note the sales tax paid as a donation on his or her personal income tax for the year.

Persons using the church credit card should prepare and provide to merchants a sales tax exemption form, available from the church office. If no exemption form is used and tax is paid, the amount of tax is owed to the church by the purchaser, and may be paid by check when receipt and card are returned.

Resources Report: Buck's report is attached to the end of the minutes. In addition to his report, he indicated that the stewardship committee was concerned at the lack of response to the Table Talk luncheons, as only about 50 people attended. He also reported that as of today's meeting, \$135,743 has been raised so far in the stewardship campaign from 57 pledging units.

Minister's Update: In addition to her filed report, Cathy shared the following:

At the dinner with Jake Morrill from UUORC and at the Sunday service presented by Cathy and Pam, a lot of excitement and enthusiasm was generated. The activities included visioning and asset mapping. See Cathy's report for details on these.

Religious Growth Report: Cecile reported the following items.

- The Civil Rights trip to Birmingham was a success.
- OWL has concluded for the year. OWL for younger children will be offered next year.
- The RE Retreat planned for April 30, 2016 will be postponed.
- Emily Sarton has agreed to be the new RE chair.

Outreach Report: Linda Park's report is attached at the end of the minutes. She made special note of the following items:

- On Monday, May 2 a prayer vigil walk across the bridge--"Silence the Violence"--will begin at 5:30 pm in Coolidge Park. The Chattanooga Police Department is sponsoring the event.
- The UUA website has a map that indicates which UU churches across the U.S. have put up a Black Lives Matter banner.

Congregational Life Report: Greg reported that coffee hour is going well and people are regularly bringing snacks to share.

New Business

- a. "Black Lives Matter" report Monique contacted Carlton Smith from our district and asked him for information on what other churches are doing in regards to Black Lives Matter. So far, she has not heard back from him and will contact him again.
- b. Evaluation of Developmental Ministry This process will be continued to the May board meeting to allow more time for board members to give their input. Monique asks that board members forward their responses to her.
- c. Statement of Congregational Sponsorship As Pam looks forward to beginning seminary at Meadville Lombard Theological School this fall, she is beginning the process of applying for aspirant status with the Ministerial Fellowship Committee. One requirement is a Statement of Congregational Sponsorship. The board wholeheartedly supports sponsoring Pam. Accordingly, sponsoring her will be presented as a motion from the BOT to be voted on at the congregational annual meeting in June of this year.

Quick Report Items

Small Group Ministry – It has been difficult to find members willing to serve as
coordinators for small group ministry, so an ad hoc group met to brainstorm possible
solutions, since SGM is a vital program in helping members establish closer friendships

and in integrating new member into the congregation. The group decided that to keep small group ministry functioning for the 2016-2017 fiscal year, they would use SGM budget funds to pay Don Donnart a \$250 stipend during the months of May and June and a \$600 stipend during the 2016-2017 fiscal year to coordinate and administrate the ongoing activities.

- Transition Team report No one from the Transition Team was present to make a report.
- Next meetings May 25, 2016 and June 16, 2016
- Annual Meeting will be held on June 12, 2016
- Opening/closing readings for May Daidee
- Process Observer We are becoming more aware of healthy communication by refraining from interrupting, listening without reacting, and giving everyone a voice. We continue to stray from time to time, but are self-correcting more often.

Closing Words: Bill read our closing words. The meeting was adjourned at 8:40 p.m.

A. **Identity. Vision and Mission.** Who do we say we are, to ourselves and to the world? How do we express the unity that binds us despite our humanistic and spiritualist differences?

Invited Jake Morrill to facilitate a dinner brainstorming event that was energizing and inspiring. Congregants were invited to brainstorm and dream. Linda Helton consolidated the data collected during the asset mapping exercise attached to the body of this report.

Visioning produces many ideas: Preschool, satellite churches (Ex. Dalton & Cleveland), a UU Christian group, campus ministry outreach, community garden, intern minister, after school program at UUCC for at risk kids.

I am in the middle of training to be a volunteer Chattanooga Police Department Chaplain. The training has been intense but when it is completed, my commitment is to be on call for 24 hours no more than once a month and to ride along with officers 4 hours per month. This arose out of a personal invitation from Chief Fletcher whom I met at a Third Way meeting at Judith Pedersen-Benn's house.

I am impressed with the efforts that Chief Fletcher and the mayor are making to change the systemic root problems that result in gang violence. I believe it will reflect well on UUCC to have their minister engaged in the community. Some people, however, have expressed concerns and this should be discussed openly because it will offer insight into the question, "Who do we say we are to ourselves and to the world?"

The CPD Chaplains Association was looking for a volunteer bookkeeper and I asked Beth Terry if she'd be interested. She enthusiastically accepted!

I wrote an article for the Times Free Press that was published on April 6, and it resulted in an invitation to attend a meeting at the Family Justice Center to discuss ways to empower communities in our City to overcome trauma and violence.

We planned a Community event for families at the Bessie Smith Center on June 16th, from 12-4 pm which will bring together individuals, families, groups and communities to provide a learning experience for everyone.

The Family Justice Center has asked to use the forum room all day on June 6 for a Tennessee Promise Initiative. It will be a daylong discussion around providing support, resources, and more to non-traditional and first generation college students.

B. **Covenant and Safe Community Policy**. What are the standards for the relationships we want to have with one another? How shall we respond when behavior violates these standards?

The covenant/communal promise draft that was overwhelmingly supported by the congregation will be submitted for a final vote at the annual meeting. The final covenant will be used on Sunday mornings, in small group ministry, in committee meetings, and in our new member ceremony.

We journey together bound in the interdependent web of all existence. We embrace diversity, own our conflicts, and assume good intentions. When we fail, we begin again in love. Justice and compassion shall be our watchwords and beloved community, our goal.

C. **Member Engagement.** How do we build a larger core of active members? Are there programming changes that will help? How do we identify and build the next generation of church leaders? How do we build a financial stewardship tradition that will sustain the church?

Completed the 12 session Harvest the Power curriculum on March 30th. The class will be offered again in the fall with some changes to format.

I attended Small Group Ministry Institute in Knoxville along with three other members of UUCC. I attended the membership committee meeting, Lay Pastoral Care Committee, the Transition Team meeting, the DRE, Wendy Sapp, and attended a meeting with Ken Brandenburg regarding making the best possible use of our space.

Another fall offering to engage our young families will be a small group ministry program called *Evensong for Families*. This program is scheduled to begin the second Sunday Sept and continue monthly for eight months. Assisted by the RE Director and others, we will begin at 4 PM for the program followed by a meal.

I met with two members interested in forming a Liberal Christianity discussion group. We will begin studying *Understanding the Bible: An Introduction for Skeptics, Seekers, and Religious Liberals* on Wednesday night, May 18 or 25 depending on the date of the board meeting.

I worked closely with Stewardship Committee selecting theme, designed the kickoff postcard, wrote a message for brochure and used the pulpit to further the message, and I attended two of the three table talks.

We welcomed two new members on Stewardship Kickoff Sunday, March 27th.

Met with two members to plan their memorial service that included an additional meeting with family members at the home.

Supported the Seder Supper, provided a new program and co-led with Lee Solomon.

I invited two new interested visitors to coffee to answer questions and share how they can get involved in the life of the UUCC community. We are meeting tomorrow morning at Niedlovs.

- D. **Governance.** How do we extricate our Board of Trustees from the ever-flowing nitty-gritty of ministerial decision making to create time for governance and strategic thinking? How do we develop policies that will make our decision making more consistent?
- Ensure the policy revisions be completed in time for the board to review them before an annual meeting vote.

- Hold a brief forum after church the Sunday after each board meeting to answer questions and listen to congregants.
- Designate time for mission/vision work either in monthly board meeting or schedule a second monthly meeting.
- Schedule four mission and vision workshops with the congregation with the goal revising the mission statement and creating a vision for the future.
- Appoint a long-range planning team
- Evaluate Developmental ministry; how are we doing? What have we done well and what do we need to accomplish next year?

Better Communication. What procedures and habits must we build to make decision making as transparent as possible and build trust within the community? How do we do a better job of telling our story to the larger community?

The newsletter has been well-received and I am still hoping UUCC will be able to add additional services such as website and membership database.

After service board member conversations monthly would be a simple way to achieve the goal of making decision-making transparent and trustworthy.

Social Justice

The Social Justice Committee is sponsoring gatherings showing an educational series of films and discussion on racism in the U.S. and the "Black Lives Matter" movement:

Thursday, April 28th – watch a PBS series "Eyes on the Prize – Then and Now" and a Ted Talk by Clint Smith about "How to Raise a Black Son in American" with discussion to follow.

Thursday, May 27th - "Crash", a film that tells interlocking stories of whites, blacks, Latinos, Koreans, Iranians, cops and criminals, the rich and the poor, the powerful and powerless, all defined in one way or another by racism. All are victims of it, and all are guilty of it. A discussion will follow.

The Social Justice Committee continues to work on 4 major projects:

We participated in the MLK events in January and are planning a series of events to educate and activate around the issue of non-violence, violence in Chattanooga and gun violence in general.
- Diversity Issues Work with other groups to address Diversity Issues: Gay/Lesbian/Transgender; Racism & NAACP; Women's Freedom of Choice...as these events come up we will be communicating to the members/friends of UUCC.
- 4. Move to Amend & Growing Inequality We will be hosting Speakers/Forum/Movies around these issues.

Committee Expo & Sunday Service

The Comm Ctee would like to, in coordination with other committees and a Sunday service representative, help put on a Committee Expo during a Sunday this summer. We plan to have committee tables, like at an expo, promoting and explaining the committee's' work. There could be a mingle and circulate time, and then a brief presentation time. Committee's would have set amount of time to present themselves, answer questions, and listen to other committee presentations. Members and friends attending this service/expo would get introduced to the various committees that help make things happen at UUCC, and perhaps would become interested in volunteering. Cyber Savvy

The Comm Ctee would like to help members and friends with their tech questions and problems. The Ctee has asked the Forum chair (Chuck Mehan) if Forum is taking a summer hiatus, and if so may we use 4 Sundays to offer this "Cyber Savvy" service. We are hoping for Sundays in July or August.

Long Term Planning

The Comm Ctee has begun talking about long term planning, what it means, and what it will look like. We would expect that one component of long term planning for UUCC overall would be to make the transition from a smaller "everyone knows everyone" semi-informal volunteer system to one that is based on taking a business systems approach where deliverables by committee, roles, and responsibilities are well defined and set out.

Thus, we plan to take that approach and will review our various deliverables and define roles and responsibilities. This will help us as we seek volunteers to flesh out the committee.

We await the development of a mission statement, since we know that our plans and projects should serve that mission statement. However, we have started to discuss reducing the number of tools we use, seeking out tools that offer a multiplicity of forms (for example, a WordPress template for a website that has a WordPress newsletter plugin). We also feel long term that we should develop a strategy of creating content once, and then using it in the many places it should go. This will reduce errors and duplication of effort.
