Treasurer's Report

July 2018

June 2018, end-of-year issues

- 1) The pass-thru account for the Social Justice Workshop (2319-000) was showing it overspent by \$78.10. I reversed 2319 by transferring it to the Social Justice expense account (6167), which had a positive balance of \$26.16, as of June 30. Therefore, the end-of-year totals show \$0 balance in the Workshop account while Social Justice expenses were overspent by around \$52, compared to the 2017-2018 budget.
- 2) The total loss for 2017-18 was \$4585.75, rather than the \$18,000 we had budgeted. This amount was moved from the Church of God restricted account (3218-001) to the Church of God income account (4708), in order to balance the income and expenditures. As a result of this action, as of June 30, the Church of God restricted account (3218-001) shows \$43,414.25. Starting in July 2018, we are posting the monthly checks from the Church of God rental into the income account (4708). Therefore, the restricted account will not change this year, unless we spend from it or if we have an excess income over expenses in June 2019 to add back to it.

Balance Sheet (Assets and Liabilities) -- July

- 1) Between the Checking and Money Market accounts, we appear to have enough cash for 5-6 months, if expenses continue to be \$10,000 \$12,000 per month.
- 2) Part of the T-bills investment matured in the middle of July, as reflected in account 1365. The Duncan Endowment T-bill will mature in January. (See also income below.)
- 3) Note that DRE Search (Account 2303) has \$359 remaining. Moving expenses of \$910 were taken from Contingency (Acct 6510, budget \$1000). The remaining DRE Search could be used, in order to leave around \$450 in Contingency. Or, if the Board would prefer, the \$359 could be transferred into Ministerial Search/Sabbatical (3245-109). Doing so would bring Ministerial Search to \$6303.88. We have budgeted an additional \$9,000 for Ministerial Search by June 30, 2019.

Income/Expense Statement (Incoming versus Outgoing Cash) -- July

- 1) The current year pledges (Account 4030) for July totaled \$20,642, compared to the budgeted revenue of \$14,269. Part of this was pledges which had been pre-paid and which were moved into the current fiscal year.
- 2) There was no Cell Tower (4703-005) rental this month, because we received 2 checks last month. This will throw the budget off-balance for the fiscal year, because we will receive 11 payments in this fiscal year instead of 12.
- 3) Church of God (4708) rental income is now being posted as income, not as restricted.
- 4) The regular T-bills earned \$413.46 in interest and dividends; the Duncan Endowment T-bills, \$168.76. Interest on the prior CDs ran around \$20-\$40 (so Bill's idea is paying off).

- 5) On the expense side, the Administrator's salary will likely vary from budget, due to extra hours having been added for *nUUsletter* production.
- 6) Worship Programs expenses (6170) are higher than budget, probably due to invited speakers.
- 7) Security Management (6335) and Janitorial Service (6530) look higher than budget. The former is billed quarterly, I believe, and the latter had 2 months covered in July.
- 8) The unbudgeted \$1.50 charge on Bank Charges (6505) occurred because a congregant's pledge payment did not clear the bank, so the bank charged it back to us with a fee.
- 9) Total income = \$23,897. Total expenses = \$9,482. Total "profit" for month = \$14,415.

Endowment Fund at the end of July was \$97,491.

RELIGIOUS EDUCATION AUGUST 2018 BOARD REPORT

There is something that needs thoughtful consideration, discussion (now or at a future BOT meeting) and input from the Board to let the RE Committee know how they should proceed with the following matter.

At the August 4th retreat for the RE Committee the following question came up. When does a child brought up in the church or participating fully in UUCC and our religious education program become of "member" of the church? According to the bylaws and policies of UUCC this is where we stand as a church regarding membership, and in particular the age of possible membership.

UUCC Bylaws passed in June 2012:

Membership

1. Any person, 16-years or older, who is in sympathy with the purpose, goals, and programs of the UUCC may become a Voting Member upon signing the Membership Book. Signing the Membership Book shall be understood to imply: agreement with the Principles and Purposes of the UUA; an intention to participate in church activities, and to make an annual financial contribution of record equal to or greater than the combined annual dues paid for each member to the Southeast District of the UUA and the UUAÇÖS Annual Program Fund.

UUCC Policy Manual:

Membership Policies Pathway to Membership Policy

Thank you for your interest in becoming a member of the Unitarian Universalist Church of Chattanooga (UUCC). We hope that the following guidelines help you understand the steps involved in becoming a member.

If you have not been a member of another UU church, completing the following steps will lead to your becoming a Voting Member of the UUCC. According to the church's Bylaws, Voting Members can participate fully in all aspects of church life, including voting at congregational meetings (one month after becoming a Voting Member), serving on the Board of Trustees, and chairing or serving on any church committee.

With this in mind, the RE Committee would like feedback from the Board as to if we should put together a class specifically geared toward grooming students toward membership during a ceremony at the end of the school year after which or during which they turn 16. Iris is checking into curriculum possibilities to prepare students to understand what "in sympathy with the purpose, goals, and programs of the UUCC" means with the idea of offering the class every two or three years for students approaching 16 years of age who are interested in committing to becoming a full member of the church at any time after they turn 16.

Religious Education Report for August 2018

Pre-K-12 Religious Education/Family Ministry

RE Committee held a Saturday strategy and planning meeting at Gale Audier's home August 4 to set the RE curriculum and calendar for the 2018-19 year. A committee covenant was drawn up and accepted.

This is what is in the works with Iris DeLaPaz spearheading these efforts.

While looking to the future of our program, the R.E committee hopes to shift from "religious education" to "Family Ministry" because we are **all** tasked with growing our spirituality, faith, and identity **together**. We hope to do this by moving into a full-week faith model, this will bring our community closer together, hold up our congregation, and build UU identity.

How do we move into a full-week faith model? We find ways to engage the community in worship outside of Sunday. A small way we are doing this is through weekly emails to our families and by providing our youth with take-it-home sheets. Other ways we hope to make this shift require congregational support and I hope the board will consider helping out with some of the special events.
