# **December Board Report - Religious Growth**

#### **Return to In-Person RE**

- 1. Ready to begin in January with 3 classes
  - a. Spirit Play (K-3rd) with Emily and Talia
  - b. Saplings (4th-8th) with Wendy S and Gale
  - c. Teens (9th-12th) with Dave and Dylan
  - d. Still scheduling specific dates and assistants
- 2. Voted to approve curriculum
  - a. Spirit Play for Spirit Play
  - b. Soul Matters for Saplings and Teens
- 3. Amanda (DRE) will prepare lesson plans and supplies for the entire month of January
  - a. She will be out the first two weeks, though (medical)

## 4. Voted to approve safety measures

- a. All children (3 and up) will be required to wear a mask at all times in the building, until such time as the Board determines that the covid numbers for our area are sufficiently low enough to do otherwise.
- b. Children and youth who are eligible to receive the Covid vaccine are asked to send a picture of their vaccination card to the office, and will be placed in the church database as having been vaccinated. This is following the same policy of the adults to streamline checking in for Contact Tracing purposes.
- c. Each classroom will have an attendance sheet anyway that will be turned in at the end of classes and will be kept on file to allow for contract tracing as needed.
- d. Every person entering and exiting classrooms will be asked to use the hand sanitation stations mounted in the classrooms.
- e. Teachers/Aides will be asked to have proof of vaccine on file with the church office.
- f. Teachers will be supplied with cleaning products in each room, and will wipe down all tables, chairs and door knobs before starting class and before leaving the classroom for the day.
- g. Every effort will be made to allow for as much social distancing as possible during the RE class time.
- h. NOTE: All children and youth will sign in and show proof of vaccination upstairs as adults do.

# **Coming Soon**

- 1. Labyrinth
  - a. Enough volunteers, yay
  - b. Happy Solstice everyone!
- 2. Nursery is not available yet (this is NOT RE committee's responsibility, just a note)
- 3. Unfortunately the playground is NOT safe to use yet

- a. We have an \$1800 budget from Spring Fling donations to address this, and intend it to be a spring project (because weather)
- 4. Hoping to restart OWL soon
  - a. Need to recruit and train teachers for it
  - b. Community outreach and collaborating with other churches to get more children and teachers (UCC, Grace Episcopal, etc)
  - c. Top priority is for 7th-9th, then 10th-12th (because they missed out during pandemic), then 4th-6th, then K-1st
- 5. 2nd Sundays are intentionally multigenerational
  - a. 5th Sundays are for service projects, but January may not get one (too soon to plan)

#### **Just Past**

- 1. Coat drive was successful
  - a. However, RE kids were not really involved. Hopefully this improves with being in person
- 2. No-rehearse Pageant was successful
  - a. Plenty of engagement in person
  - b. Didn't translate as well to online streaming, since the audience was part of the fun
  - c. Thanks Amanda and those who participated (especially reading)

#### **DRE Search**

- 1. Committee met recently to discuss desires and priorities, and set deadlines for next steps
  - a. We will list interview questions by January 11
  - b. We will decide on advertising details and methods by January 11
  - c. Next meeting is January 11 to finalize these
- 2. Intend to place ads in February (teacher jobs usually start posting in early spring)
  - a. Start interviews after a few weeks (late February)
  - b. Begin position by April so they can overlap with Amanda
- 3. Looking for a local teacher, not necessarily UU trained, preferably with a specialty (music, dance, science, etc), prioritizing intersectionality (diversity and/or awareness of)
  - a. Position will be for 20 hours, focused entirely on children (as opposed to lifespan)
    - i. Aim to integrate RE with congregation
  - b. with an emphasis on middle and high school ages
    - i. That's where we already have a higher need for engagement and are losing their interest, haven't maintained bridging ceremony etc
    - ii. It's when most people develop agency and make decisions about religion/church separate from their parents (we want them to choose us)

#### Outreach

VP Outreach board report: submitted by John Standridge December 2021

#### **Outreach Ministry Committees**

- Membership – members: Jon Littlefield, Roger Davis & Christine Hunt. – Jon Littlefield and Roger Davis are co-chairs of the membership committee. The plan remains to re-imagine what membership will look like using a CRM (customer relationship management) approach that will monitor the status of visitors, attendees, and member involvement in committees, as chairs, and as board members. The hope is that we can develop mechanisms in the church to signal first-time attendance and that we can encourage a culture that "everyone in the church is on the membership committee".

Outreach -- We have begun to carry out WUTC messages and will be using the \$846.80 designated for that, and the \$475 communications/advertising budget to carry that out if needed. Our current messaging this week is to promote the Labyrinth which occurs on the winter solstice. Jon Littlefield contacted Dennis Parker, our WUTC contact.

The audio-visual project remains within budget. Unfortunately, the production quality, especially the audio, remains substandard (a loose or faulty cable?). This should improve with professional sound booth personnel beginning in January. Our hardware includes 2 top-of-the-line speakers (15" Electrovoice) and 2 subwoofers; a Yamaha 20 channel soundboard; a computer for adding features like Zoom, streaming website video, producing YouTube uploads and more; a Network upgrade, cable and router for high-speed internet; an electrical upgrade; Access Point wi-fi architecture, router, and a "Smart" TV for R.E.

- Public Relations/Communications Gary Beale has agreed to continue in his current role in the audio-visual project as our designated communications committee co-chair. With able assistance from Farin Cloyd, and with messaging from Jon and Roger, they will manage social media: write for the web, proofread, draft press releases, and maintain a media contact list. The current website and Facebook pages look great! Much improved!
- Beloved Café is up and running with two services a month, 1<sup>st</sup> and 3<sup>rd</sup> Saturdays. This might be among our next WUTC promotions.
- Social Justice Members: inchoate. Judith Gallagher and Robert Childs are the *de facto* co-chairs. The committee has produced a slate of organizations designated for Donate the Plate for 2021-2022, and is now seeking volunteers to handle speaking arrangements for those organizations.

We continue to grow our Lifespan Religious Education Program by investing in digital resources. We are strengthening the Digital Community Manager concept, not with an individual, but as a team.
