VP Resources, Amy Kussman

- 1. **Talked to Dave B. about changing up the Landscape Committee,** with a possible new Chair to take over Bonnie's spot.
- 2. Window Coverings for Office: Update: I talked to Farin and she is looking into how much we paid for Rev. Mandy's window coverings. I would like to know the top amount I could use for these coverings because they will have to be a special order, due to their size. We have measurements of the windows in Farin's office-searching options to purchase shades similar to the ones in Rev. Mandy's office (beige or cream colored).
- 3. Locks on Forum/RE/Nursery: Looking to replace the locks with a lock similar to the front door. Currently, the front door is the only way in and out of the building. Had an issue in the past where we couldn't get in the building, after an attempted break in. We'd like to have a way for kids to leave the room and go to the playground, without worrying about getting locked out.
- 4. **Pines are dying out on our property.** Several pines have fallen, and have been bucked up already...but there are more standing dead that need to be removed. The pines will naturally be replaced with the upcoming hardwoods, but we will have to stay on top of their removal to avoid any injuries.

FINANCE COMMITTEE MINUTES

May 12, 2022 – via Zoom ---- *DRAFT*

Recommendations and Information for the Board of Trustees

- 1) Facilities Repair/Maintenance (6325-500) exceeded its budget in April due to the unexpected plumbing repairs.
- 2) The Finance Committee believes that to lower Lewis Property Tax (6527) from the current annual \$500 would require some type of structure to be built on the property.
- 3) The 2022-23 budget will be sent separately to the Board for approval before the annual church meeting. In its current form, the budget results in a \$23,000 deficit.

MINUTES

Present via Zoom: Chair: Christian Horvath, Daidee Springer, Bill Derrickson, Rodger Miller, Chen Zhang, Andy Foskey, Amy Kussman and Lynna Ruth Standridge.

Chalice Lighting and Reading: Christian opened the meeting at 6:36 p.m. Christian lit a virtual chalice and Daidee read *Fragility/Divinity* written by Jill-Beth Sweeney Schultheis from *For All That is Our Life*, a meditation anthology edited by Helen and Eugene Pickett.

Reports by Acclamation:

Minutes from April FC meeting

Minutes of the April 14, 2022, FC meeting were approved by acclamation with many thanks to Daidee.

April Financial Reports

The Balance Sheet for April is notable because the cash accounts, checking in particular, continue to go down. FC would like the \$0.05 in the Poinsettias account to go away [Note: Lynna Ruth did this after the meeting]. The committee questioned what is in 3209-407 (AV). Lynna Ruth looked it up and reported that it was a payment to Sweetwater Sound, so it is correctly posted. A previous decision to pay this account from the Very Temporary account will not work, as it has a balance of around \$40.

The Income and Expense Statement drew several discussions. Cell Tower income appears to have been paid for two months. It will increase on a monthly basis, from \$1,637 to \$1,673 for now, and then increase again by \$375 later in the calendar year. On account 6050-406 (Ministerial Search/Sabbatical), Finance wants that moved to 6220-200 (Youth RE), because it was an ad on Indeed for the DRE position [Note: Lynna Ruth did this after the meeting]. Account 6325-500 (Repairs/Maintenance) pushed that account over budget, but this was due to unexpected plumbing issues. Since the land has been improved, account 6527 (Lewis Property Taxes) was discussed in terms of getting the tax lowered. However, the committee was reminded that we would need a structure of some type built onto the land. No decision was reached by the committee, as this probably would need to come from the Board.

Old Business:

Duncan Investment & Fidelity Brokerage Accounts Controls

Bill spoke to Fidelity about what control church individuals might have over those resources. He learned that distributions could only go to our church checking account, not to any individual's checking account. Bill also asked about professional management of the account, due to recent losses. Fidelity will charge 1.5% to manage the investment accounts, and Bill will work on the paperwork for this.

2022-2023 Stewardship Campaign

The campaign has started and is ongoing. Pledge cards were given out at the Sunday service or mailed out. Chen and Rev. Mandy are doing a follow-up mailing to convey some urgency. The committee is still working out various details. We were reminded that the pledge cards will need to be collated into a spreadsheet. Christian suggested that the committee will need the next three Sundays to push for the pledge cards, which makes May 29th the potential 'end'. The annual meeting is scheduled for June 12th and the budget has to be available two weeks prior, or May 29th. The committee will still be asking for pledges up into July and perhaps August, and may do a second push later in the year.

Reports about Financial Status in nUUsletter

Daidee shared a 'blurb' from another church. After some discussion, the committee suggested a few small changes

and agreed that the monthly information could start in two weeks after Farin returns from vacation. Cell Tower Signage

Bill spoke with Crown Castle. They will switch the faded sign panel with the one opposite, which is almost pristine,

repair handrails and deal with mold in the outbuildings. He expects the additional \$375 per month rent will start

afterwards, but has no detail on the work timetable.

2022-23 BudgetEveryone agreed that this budget is too optimistic. After a very long discussion and working with the numbers,

Christian created a revised spreadsheet, which showed \$192,312 income (\$150,000 pledges), \$161,881 personnel expenses, \$215,396 in total expenses, and resulted in a deficit of \$23,084. We suggested three possible ways to make up some of that deficit:

Need staff support to raise funds ?? amount Endowment transfer \$3,750-4,000

Use some COG funds \$4000 Remaining deficit \$15,334

New Business:

Funding Needs for Summer Environmental Program
Selina Duncan would like to have five or six environmental-themed lectures
during the summer months. She has spoken to environmental groups in the area,
who have agreed to send speakers. The committee agreed that Adult
RE (6210-200) would be the appropriate account, but the precedent at the Forum
was to not pay speakers.

Endowment Committee Report:

The value of the endowment fund at the end of March rounded to \$135,906. The value at the end of April was \$128,851 – or an approximate \$7,000 loss for the month.

- 1. Camille Mason is our new Director of Religious Education! Yay!
