The Finance Committee will review the budget again in January and may make recommendations to transfer funds from the money market and endowment to the general operating budget.

Andy read the letter of resignation sent to him and Rev. Mandy from music director Jennifer Wilson. Jennifer has received a promotion at work and that, along with her family obligations has decided to leave the UUCC position by the end of 2022. A plan to find a replacement is forthcoming.

Treasurer's Report Ending September 30, 2022

Balance Sheet (Assets and Liabilities)

- The checking account balance is worrisome, at \$14,860.02. MoneyMarket is at \$41,739.90, giving us cash assets of \$56,599.92.
- 2) Fidelity issued an online statement for August/September combined. Details are listed below.
- 3) The Very Temporary (2350) account now has a balance of \$67.31.

Income/Expense Statement (Incoming versus Outgoing Cash)

- Pledge income for September was \$4,991.33, which falls close to the year-to-date budget. Total income for September was \$9,893 (rounded). The year-to-date budget for total income was estimated to be about \$1,600 higher. Note that September had two cell tower rental payments.
- Expenses for September were \$15,289. Total expenses for the year are around \$7,500 less than budgeted.
- 3) Income less expenses equals a negative \$5,395.61.
- The minister's and administrator's retirement fund contributions should be caught up by the end of October.

Endowment

The Endowment Fund was \$115,648, which represents a loss of over \$11,500 since August 1.

Treasurer's Report - Draft August 2022

Balance Sheet (Assets and Liabilities)

- The checking account balance has recovered somewhat, at \$21,203. <u>MoneyMarket</u> is at \$41,738, giving us cash assets of \$62,941.
- Fidelity did not issue an online statement for August. I was able to pull the total balance for the two accounts for August 31, but not the value of the individual holdings.
- Thanks to a donation, the WUTC account is no longer 'overdrawn' and has a balance of \$51.80.
- The Very Temporary (2350) account now has a balance of \$532.31. [I looked it up, but do not have the info with me. I can email it to you later.]

Income/Expense Statement (Incoming versus Outgoing Cash)

- Pledge income for August was greatly improved at \$26,196. Total income for August was \$28,372 (rounded).
- Expenses for August were \$16,170. Total expenses for the year are almost \$5,000 less than budgeted.
- Income less expenses leaves us with a positive \$12,202.
- 4) The unbudgeted amount of \$420 was an error. I had entered the budget for Tech Salary on the wrong line item (the heading line, instead of the expense line). I have corrected that, if you want a corrected income/expense report.
- There was no payment for the minister's retirement fund, because Cass was waiting for Farin to sign up. Cass plans to make two payments in September.

Endowment

The Endowment Fund, at \$123,217, versus \$127,287 at the end of July and \$121,777 on January 1.
