Christian: Highlight Uptake in attendance. Finance: Dec really good. Think it was a lot of one-time payment for end of year gifts. Finance Committee expects pledges to go down in second half of the year, but overall better than last year. Note: Main issues they see in building issues.

Dave: Front Door needs weatherized. He can do that, but it needs to be replaced. Downstairs RE Door and Forum Door, no keys, but locks don't work. Locksmith already looked at. RE door needs replaced. Cost several thousands dollars for the doors.

Dishwasher needs to be replaced. People have asked about a water filtration system on kitchen sink. Cost may be about \$400. \$1000ish for both dishwasher and filtration system. Mandy: A capital campaign is needed over the next couple years.

John: Updated — re: WUTC budget. See notes below. Leaves one spot per week through June.

All approved the board minutes and committee reports.

Treasurer's Report December 2022

Balance Sheet (Assets and Liabilities)

1) The checking account balance has continued to improve, and now is \$19,549.71. MoneyMarket is at \$41,777.19, giving us cash assets of \$61,326.90. This picture has improved over the past few months.

2) The Staff Christmas Gift pass-thru account, 2380, shows a negative \$50.00, because a promised check has not yet arrived in the mail. The donor is aware and is researching the issue. When it arrives, it can be posted to either December or January.

3) The Fidelity balances noted on the balance sheet and below are based on the statements Fidelity issued. Note that the Fidelity balances on the Balance Sheet have been updated.

Income/Expense Statement (Incoming versus Outgoing Cash)

1) Pledge income for December significantly improved at \$21,823.11. Year-to-date (YTD) pledge income exceeds both the YTD budget and the YTD for the prior year.

2) Total income for December was \$25,710 (rounded). The YTD Total Income, at \$100,988, exceeds the YTD budget by approximately \$4,800. YTD Total Income also exceeds YTD Prior Year by over \$8,400.

3) Expenses for December were \$16,228. Total expenses for the year, at \$95,806, are over \$11,600 less than budgeted.

4) Income less expenses for December gives us positive cash flow of \$9,481.45 for this month versus \$5,181.97 for YTD. The YTD excess income is almost \$16,500 higher than budgeted.

Endowment

The Endowment Fund was \$121,965.09, a loss of \$3,475.48 over November. For the calendar year, the fund had deposits of \$20,000 and investment losses of \$19,829.46, for a net loss of \$170.54 over the twelve months.

<u>Fidelity Mutual Funds</u> -- The total of our account on 12/31/2022 was \$87,293.27, a loss for the month of \$3,919.24. Fidelity did post a statement for December. These numbers were based on a January 1 report, but vary from the statement by pennies.

Chalice Lighting & Reading:

The meeting came to order at 6:37pm with Rev. Mandy lighting a virtual chalice and Lynna Ruth giving a reading, Until "All Means All" by Erika A Hewitt. The reading was selected and sent to the FC by Brianne Brucker who was unable to attend the meeting because of family responsibilities. We're looking forward to her being among us next month.

Minutes from previous FC Meeting:

Because there wasn't quorum at the December FC, no actions were taken. But Bill & LR provided minutes of that meeting. Those minutes were approved by acclamation with gratitude for the fruitful discussions.

Financial Reports:

The Treasurer's report is attached to these minutes. Highlights include:

· Checking account balance has improved significantly from last month

• Pledges are coming in well. They exceed pledge amounts from the same time last year and also exceed our year-to-date expectations. However, we expect pledge income to drop in the next months because a number of "big donors" used their RMD's to fulfill their pledges before the end of the calendar year.

• Offertory plate income is also better than budgeted for the year and above that for this time last year

 \cdot Expenses for the fiscal year are over \$11,600 less than budgeted In addition:

 \cdot The \$50 deficit that appears on the balance sheet for Staff Christmas Gifts (account #2380) will be erased on the January balance sheet. The promised check arrived in the church office this week

 \cdot The Memorial Garden bank account has been moved to the Tennessee Valley Credit Union where it will no longer be subject to monthly fees. The current balance is around \$4,000

• The tax tables in PowerChurch have been updated to reflect 2023 changes

• Fundraising income is primarily a result of art sales and a poetry night

The FC agreed that the balance sheet should be further cleaned up by moving the \$8 in the Flower Fund, account # 3230 and the \$74 in the Endowment Holding account # 3220 to Unrestricted Net Assets, account # and transferring the \$42.31 in Account #2350, Very Temporary, to the Benevolence Fund.

 $\cdot\,$ It was also noted that Social Justice should be reminded that there is \$95.76 in their temporary restricted account, #3279

· Rev. Mandy mentioned that the 30 Days of Love theme will focus on giving and sharing

 $\cdot\,$ As previously noted, expenses are lower than expectations for the year, a few line items are over budget. Among these are:

Account # 6155, Music. Not to worry here

Account 6325, Repairs/Maintenance Facilities This is primarily because of painting of stripes on the parking lot

Account #6509, Computer Services. We are moving towards canceling Zoom and using GoogleMeet (which is free) for online meetings. In addition, WordPress and GoDaddy may have contributed to the overage here

• Lynna Ruth reported that w2's and 1099's have been filed electronically. Staff can pick up their hard copies in the church office. Copies will also be sent by snail mail. Total salaries and wages for 2022

were \$110,480.76.

• A suggestion was made to send the UUA half of our annual dues now. After discussion, it was agreed that we will stick to the original plan of waiting until towards the end of the fiscal year to determine how much we can afford to give the UUA. That plan was agreed to when the budget was passed last June

Old Business Utility Cost Analysis

Dave reported that costs connected to heating with natural gas go up and down like a yo-yo. A lot has to do with the weather. Our savings seem to be in electricity, not gas. Dave also pointed out that we heat the building for 3 or 4 months a year while we use air conditioning 8 to 9 months per year. Green Switch Follow-Up

Update: We are now set up to have one 15-second spot of WUTC messaging per week through June, but we do not have an advertising budget for additional spots. Our last radio messaging was to promote Dylan's reading of Dylan Thomas in December. Dennis Parker and Rob Beckett are our WUTC contacts. The effectiveness of the promotion was disappointing in terms of community turnout and return on investment. We took in \$243, but WUTC ads ran \$510 in December, with \$306 going toward the Dylan Thomas program.

We are consistently producing our Sunday service and a few other activities on YouTube. The production quality is very high.
